

Ormiston Town Centre "Shop. Play. Win." ("**Promotion**") – Terms and Conditions

1. Ormiston Town Centre Limited ("**Promoter**") and/or its representatives will offer the Promotion to customers of Ormiston Town Centre on the below Terms and Conditions.
2. Information on how to claim and the Promotion form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
3. The Promotion commences at 9.00am Saturday 2 August 2025, 9.00am and entries close at 10.00pm on Sunday 31 August 2025 ("**Promotional Period**").
4. The Promotion is for the chance to win one of two (2) \$500 vouchers from New World (Ormiston Town Centre) and one of two (2) \$500 vouchers from Pak N Save (Ormiston Town Centre) to be given away during the Promotional Period.
5. There will be one (1) ("**Draw**") conducted for the entries received during the Promotional Period per week. Entries into the Draw will open and close on the dates/times outlined below. The Draw for the prize will take place at Ormiston Town Centre, 240 Ormiston Rd, Flat Bush Auckland, New Zealand, 2019 ("**Premises**") on the dates outlined below.
